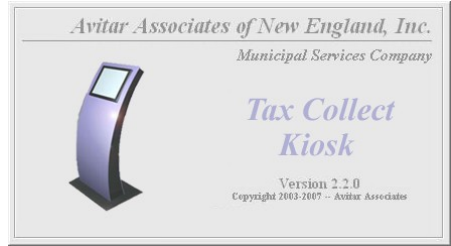

## Avitar Tax Collect Internet Kiosk

The Avitar Tax Collect Internet Kiosk allows Tax Collectors to easily make their invoice and transaction records available on the Internet so that taxpayers, mortgagees, banks, and title companies can view and even pay taxes at any time of day without having to contact the Tax Collector.

- The Tax Collect Internet Kiosk is hosted on Avitar's web site so there is no configuration or maintenance that must be provided by the municipality. Avitar provides the municipality with a unique URL link that the municipality can place on its own web site, include on tax bills, or publish in newsletters or newspapers.

- Certain elements of the web site can be customized for the municipality, showing specific contact information, office hours, or even letter head or town seal images.
- Tax information is posted directly to the Internet by the Tax Collector from within the Avitar Tax Collect program. Information can be posted daily during tax season or more infrequently at other times of the year, using a simple export similar to the process of exporting information for real estate tax services.
- Internet users access the system directly and anonymously, without the need to purchase a subscription or obtain a username or login. Unlike Avitar's online municipal assessing database which requires end users to purchase a subscription, the costs of the Tax Collect Internet Kiosk are paid for by the municipality.
- Internet users can access tax information by Owner Name, Map and Lot (PID), or Parcel Address.

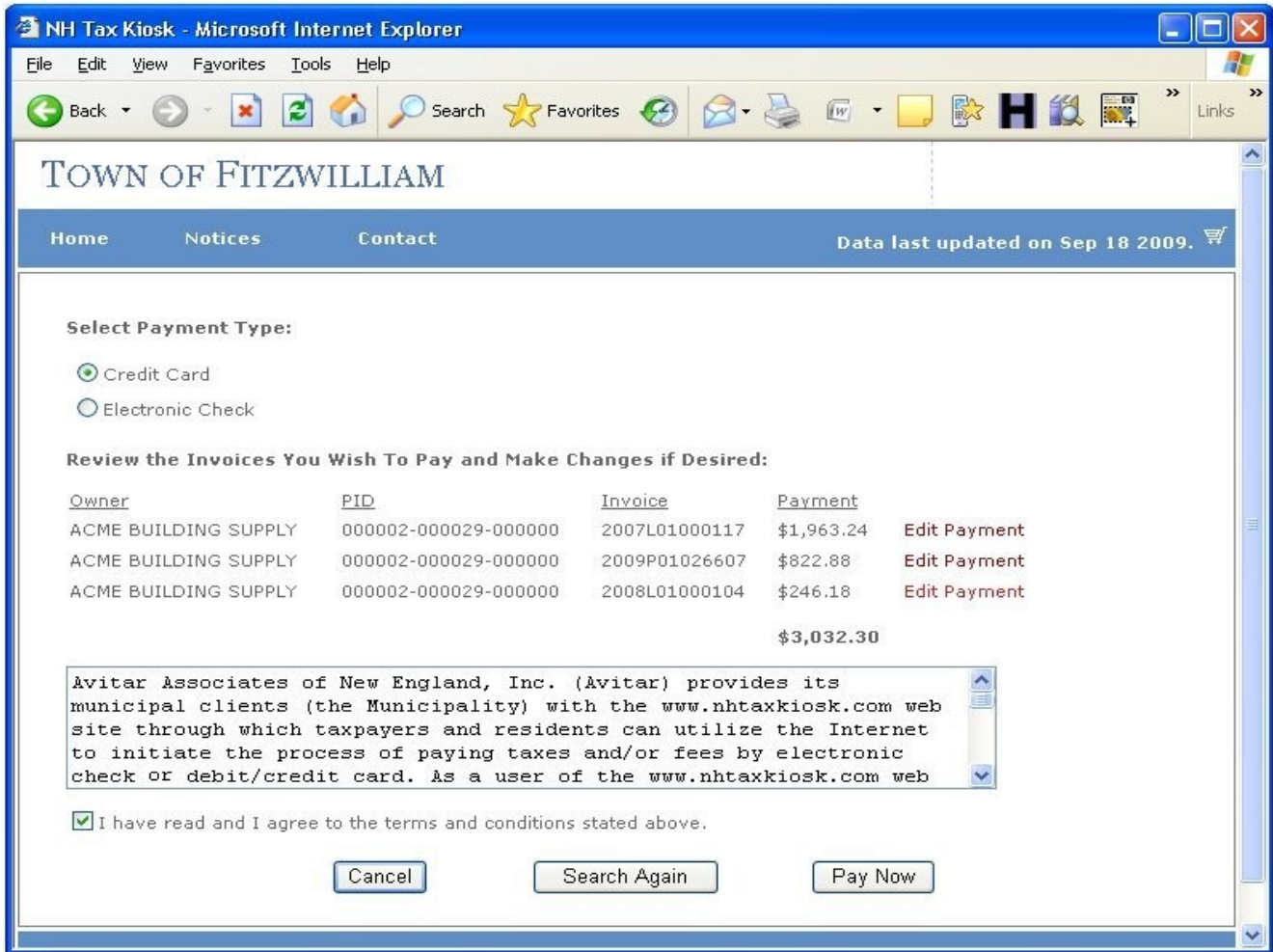

- Once an owner or parcel is selected, a list of all recent invoices is displayed, showing type of invoice, due date, bill amount, and outstanding due amount.
- Internet users can change the Interest Date to determine the proper payment amount for future payments.

- For any individual invoice, the Internet user can click the Transactions button to access additional information about the specific tax bill, including any transactions that have been made on that invoice such as payments, abatements, or penalties.
- For municipalities that choose to accept Internet tax payments, the Tax Collect Internet Kiosk can be configured to allow Internet users to make payments using a secure and safe web site.
- Prior to payment customers are directed from the Tax Collect Internet Kiosk web site to a secure web site. All financial information is collected and processed by a nationally-recognized provider of safe and secure electronic payments.



- The municipality receives 100% of the taxes paid and there is no charge to the municipality for the electronic payment. Customers are charged a convenience fee (either flat rate or percentage based depending on payment type) for the transaction.
- All financial transactions are processed through a PCI compliant service that specializes in enabling government organizations to accept and manage electronic payments from citizens and businesses.
- Pricing for the Tax Collect Internet Kiosk is determined based on a nominal one-time set-up charge and an annual usage fee.
